Veteran Car Club Membership Types

The Club has seven types of membership: Full, Associate, Young Associate, Family, Bearer (Corporate) and Junior (with or without Gazettes).

Full, Family and Bearer members can enter and drive cars in an event, an Associate member can drive a car entered by a Full, Family or Bearer member. Full, Associate and Young Associate members each receive the Club's Gazette and can vote at Club AGMs. Family and Bearer membership entitle the holders to one Gazette and a single vote at Club AGMs.

Family membership is intended for family groups where more than one family member wants to enter and/or drive the family's car in events. Similarly, Bearer Membership is intended for organisations and companies where a number of partners or employees may wish to enter and/or drive the car.

You do not have to own a Veteran or Edwardian car to become a Member. Almost half our membership are Associate members, and they have a vital part to play in the life of the Club.

Membership of the Veteran Car Club of Great Britain is Worldwide.

Full	Any age	Full members (over the age of 17) can enter and drive a car in any VCC event. Full members can also enter a car for an Associate or Young Associate member to drive. Full members each receive the Club's Gazette and can vote at Club AGMs.
Associate	36 and over	Associate members can drive a car entered by a Full, Family or Bearer member. Associate members each receive the Club's Gazette and can vote at Club AGMs.
Young Associate	17~35	Young Associate members can drive a car entered by a Full, Family or Bearer member. Young Associate members each receive the Club's Gazette and can vote at Club AGMs.
Junior (with Gazettes)	Up to 17	Junior members of this type of membership receive the Club's Gazette.
Junior (without Gazettes)	Up to 17	Junior members of this type of membership will \underline{NOT} receive the Club's Gazette.
Family	Any age	Family members (over the age of 17) may enter and drive a car in an event. Family membership entitles the holder to one Gazette and a single vote at Club AGMs.
Bearer (Corporate)	Any age	Bearer members (over the age of 17) can enter and drive a car in an event. Bearer membership entitles the holder to one Gazette and a single vote at Club AGMs.

VCC data policy statement

The VCC only collects data necessary to provide the membership services expected of it by its members, including the maintenance of membership records and publication and distribution of the club magazine, keeping members informed of news and VCC activities, provision of membership lists, vehicle identification and dating services, maintenance of associated historical records and the organisation and running of motoring and other events.
